- (g) Licensed premises, adjacent public road or roads and immediate vicinity of licensed premise will be left in good condition, cleaned up and cleared of all paper, waste materials and debris. Cash bond deposit with application will guarantee performance of terms of this paragraph and so much of said bond money shall be necessary to carry out said terms may be used by Township; balance of bond money to be returned to applicant when licensed premises are completely vacated.
- (h) Only parties interested in and intended to benefit from contemplated profits is the applicant, unless attached Participant's approval is filled out and signed.
- (i) Written consent of landowner to issuance of licenses is attached.
- (j) Applicant has complied with N.J.S. 34:15-71 and understands that under the provisions of N.J. S. 40:52-1.0 that said Township can not issue a license for a circus, carnival or other traveling show unless and until N.J.S. 34:14-71 (Employer's Liability Insurance Law) has been complied with.
